RESOLUTION AUTHORIZING INTERFUND TRANSFER FOR DEBT SERVICE PURPOSES

WHEREAS, by regulation (23 III. Administrative Code 100.50(d)(1)), the Illinois State Board of Education requires that, when revenues or other sources of funds are pledged to pay debt service on any long-term debt, the moneys shall be transferred into the Debt Service Fund;

WHEREAS, the Board wishes to authorize expenditures to pay for debt service using revenues from the Educational Fund;

NOW, THEREFORE, Be It Resolved by the Board of Education of Northfield

Township High School District Number 225, Cook County, Illinois, as follows:

Section 1. The School District Treasurer is authorized and directed to permanently transfer from the Educational Fund (Fund 10) to the Debt Service Fund (Fund 30) the sum of Six Hundred Fifty-One Thousand, Thirty-One Dollars (\$651,031), to be used for debt service obligations of the District, specifically the following: capital lease payments.

Section 2. This resolution shall take effect upon its adoption.
