

Good Afternoon, ED-RED Members,

Yesterday, House Speaker Michael

Madigan announced a series of upcoming spring meetings of the House Education Funding Task Force, the first scheduled on February 16, 2016. The focus of this session is intended to discuss the latest iteration of SB16/SB1 sponsored by Senator Andy Manar, which we expect to be introduced within the next week.

\*\*\*\*\*

House Speaker Michael J. Madigan, D-Chicago, issued the following statement Thursday announcing hearings to be held by the bipartisan Education Funding Task Force throughout the spring to help craft a legislative plan to equitably fund education throughout Illinois:

"Senate President Cullerton has shown strong leadership on the issue of fair and equitable education funding, which is so important to every community across our state. The President's commitment to fairly funding our schools and helping all students meet their full potential is one that I share, and I plan to work with him to achieve this goal while making sure that voices from across our state are heard and that all schools and programs are protected throughout this process.

"Beginning February 16 and continuing throughout the spring, House Majority Leader Barbara Flynn Currie will lead hearings of the bipartisan Education Funding Task Force. The House Democratic members of the task force, who represent Chicago, suburban areas and downstate, bring to the discussion the views and concerns of residents from all across Illinois to help ensure a comprehensive approach to any changes in how our schools are funded. The task force will hear input from educators and advocates from throughout the state, and will work with all interested parties to craft legislation aimed at ensuring all students in Illinois receive the excellent education they deserve."

The Education Funding Task Force will convene Tuesday, Feb. 16 at 10:30 a.m. in Room 114 of the State Capitol.

\*\*\*\*\*

The ED-RED Executive Board has spent significant time over the last three months discussing possible alternative funding options. Our conversations have been in conjunction with educational partners from the Legislative Education Network of DuPage County (LEND), the Large Unit District Association (LUDA), the South Cooperative Organization for Public Education (SCOPE), and PMA/Forecast 5 Analytics. In addition, our Executive Board Chair, Bob Spatz and Vice Chair, Brian Battle, along with myself, have had several substantive meetings about a new funding formula with Michael Jacoby, Executive Director, Illinois Association of School Business Officials (IASBO) and representatives from the Illinois Alliance of Administrators of Special Education (IAASE).

At the same time,

ED-RED convened a School Funding Working Group, inclusive of business officials from our membership, and representatives from LEND, LUDA, SCOPE, and Northeastern Illinois University.

The Executive Board

also decided, that while we would not officially be signing onto the Vision 20/20 initiative, we would make appointments to the Vision 20/20 committees. Cheryl Witham, Asst. Supt. of Business/CSBO, at New Trier #203 serves on the Equitable and Adequate Funding Committee, and I sit on the Advisory Committee.

While the ED-RED Exec Board

has not formally made a recommendation based on this work, there seems to be coalescing around an Evidence Based model based on the 2010 National Louis study. A version of this was presented at the November 6, 2015 ED-RED Finance Legislation Meeting.

ED-RED continues to advocate for a more fair and equitable funding formula, and like the Governor

stated in his State of the State Address, "significantly increase state support for education, focusing additional resources more on low income and rural school districts so "we can provide high quality classrooms in every community, without taking money away from any other districts".

If you have any thoughts or suggestions regarding school funding models that you would like me to bring to the working group or our Executive Board or if you would like to discuss the work we are doing further, please feel free to contact me by email or phone.

Good Morning, ED-RED Members:

This week in Springfield there was extensive conversation around education funding reform. On Tuesday, Senator Andy Manar advanced his latest funding overhaul iteration, SB 231, which narrowly passed the full Senate on a vote of 31-21-3. We would encourage you to review the vote link, and contact your district Senator to thank them for voting No or Present on the legislation.

At the same time, Brian Battle from Barrington #220/ED-RED Vice Chair and Michael Jacoby from IASBO were testifying before the House Education Task Force on the Evidence-Based Funding for Student Success formula. This formula is the work of a broad-based coalition of ED-RED partners beginning last fall, inclusive of LEND, LUDA, SCOPE, PMA/Forecast 5 Analytics, IASBO, CTBA, and Concordia University of Chicago. Please find attached talking points for your review. Then on Wednesday, both groups also testified at the monthly meeting of the Illinois State Board of Education.

While the evidence-based funding model begins to gain legislative support, SB 231, now has an uphill battle for approval by the House of Representatives. In the meantime, legislators remained focused on ensuring K-12 education is funded for FY17.

At the moment, it seems unlikely that the measure will advance quickly in the House, if at all, especially in its current form. However, we encourage each of you to contact your Representatives and share the impact of SB231 on your district based on the most recent ISBE district-by-district breakdown on 5/5/2016 attached again for your convenience.

ED-RED will continue to monitor this legislation, as we work to achieve an alternative funding formula and a comprehensive funding package for FY17.
