GBS sophomore, Olivia Smoliga, was recognized for finishing first at the state swim meet in the 50 yard free style and 100 yard back stroke. Motion by Mr. Boron, seconded by Dr. Regalbuto to open the public hearing for the tax levy.

PUBLIC HEARING: APPROVAL OF TAX LEVY

Mr. Shein invited members of the public who wished to comment regarding the tax levy to come forward.

Mr. George Stutz of Northbrook spoke in opposition to the proposed levy. Mr. Stutz provided his position regarding why he believed the proposed levy is too high.

Mr. Stutz asked the Board how they plan to reduce personnel costs. He also suggested that the Board consider cable casting the Board meetings.

MOTION TO CLOSE THE PUBLIC HEARING: APPROVAL OF TAX LEVY

DISCUSSION/ACTION: APPROVAL OF TAX LEVY

Dr. Riggle referenced the recommendation on page 1 of Mrs. Siena's memo.

Mr. Boron asked for clarification regarding the levy and special resolution contained within the recommendation. Mrs. Siena indicated that there is a resolution for the levy and a resolution directing the Cook County Clerk how to apportion the levy.

Mrs. Siena stated that it is likely that the district will not be approved for the full levy amount requested. The district always asks for more than we expect to receive. One factor that influenced the levy are mandatory contributions to IMRF.

Mr. Hammer clarified that the Board was not required to conduct a public hearing because the rate requested is under 5%. He stated that the C.P.I. is 2.7%, applicable to the 11-12 school year, and a new growth factor of 2% must be added to capture new growth.

Mr. Hammer stated that part of the levy is on new growth - the growth rate of new property. He stated that it is out of fairness to all taxpayers that the district captures new growth. The maximum new growth captured will be 2%, but if new growth is less than 2%, the district will only get what new growth brings. The new growth factor helps to provide for student enrollment increases.

MOTION TO APPROVE TAX LEVY RESOLUTION PROVIDING FOR THE LEVY OF TAXES FOR THE YEAR 2010

DISCUSSION/ACTION: ACCEPTANCE OF THE COMPREHENSIVE ANNUAL FINANCIAL REPORT (CAFR) FOR THE FISCAL YEAR ENDED JUNE 30, 2010

Mrs. Siena shared a letter from Miller Cooper regarding a prior period adjustment on physical inventory related to construction. This is a seven-year audit adjustment on capital assets.

Mr. Wolfson asked what the adjustment was in the audit. Mrs. Siena referenced note O on page 48. She reviewed the note on the adjustment in the audit. She explained that the first renovation project was \$44M and the most recent was \$84M. The physical inventory in 2003 was estimated and kept as a placeholder. Four years later the district started the referendum construction. This adjustment has no impact on those who bought bonds.

Mr. Martin asked for an explanation of the tradition of the Board accepting the audit. Mrs. Siena explained that the Board approves the line item to pay for this audit and it is a costly line item. The audit provides the Board an opportunity to know that the budget is managed in an appropriate way. In reference to the CAFR, Mr. Martin asked what the odds are of districts earning this award from the number who apply.

Dr. Riggle explained that the district participates in this process to demonstrate a solid financial base. This audit served as one of the cornerstones in moving forward with Moody's in obtaining the district's bond rating.

Mr. Martin stated that the district goes through this exercise and as a result, what do we learn and what can we say to our neighbors?

Mrs. Siena stated that this audit is the highest standard to measure ourselves by. The district is required to do an audited financial report every year. If the district did not do this there are bidders who would not have looked at the school district.

Mr. Wolfson stated that in spite of the state of the state, our bonds were priced at favorable rates because of this audit presented to Moody's. He indicated that the district obtained savings many times in the interest rate on the bonds because of the bond rating.

Dr. Riggle indicated that the district did not participate in the CAFR process until 2008. At that time the district made a conscious effort to show that it meets the highest standard in financial management.

Mr. Wolfson stated that not only does the district save on interest rates, this benefits the whole community, preserves property values, provides stability to the school system and brings people into our community.

Mr. Wolfson indicated that he is still bothered by \$40M in assets not properly accounted for. He stated that we are paying insurance on a higher number. He asked Mrs. Siena if there is

any way to smooth the curve on this. She indicated that an adjustment cannot be made at this time.

Dr. Riggle thanked Mrs. Siena and Ms. Bezanes for their hard work. He indicated that he could not ask for a more conscientious group in putting together the audit document.

DISCUSSION/ACTION: AWARD OF STUDENT TRANSPORTATION BID

Dr. Riggle stated that the transportation bid now matches how we are delivering services. The same six bidders participated as last time. All of the bids came in lower. The current bids are 15% less than the existing rate.

The final snapshot of transportation revenue as of June $30^{\rm th}$ is off because of the timing of collection of funds. Dr. Riggle explained that when we talk about student fees we provide a snapshot.

The Board asked if the administration anticipates increases in bus costs for parents. Mrs. Siena stated that she does not anticipate an increase for families.

Clarification was given in that more buses run in the morning in comparison to the afternoon, so the cost per bus in the morning is less than the cost per bus in the afternoon.

Mr. Wolfson asked why the district does not allow for a fuel surcharge in the event that gas went above a certain price as this may serve as a cost savings for the district. Mrs. Siena stated that this could be looked into for years four and five. This might not be a big savings, but can be reviewed for the future.

DISCUSSION/ACTION: APPROVAL OF GBN ROOFING WORK

Dr. Riggle explained that currently there is an emergency roofing situation at GBN. In our master plan this roof would have been up for replacement on the next cycle. If we do not fix the roof at this time this could cause costly damage. It is under the advice of ARCON that we replace the roof in a two-phase process. First, a temporary roof would be constructed and then under phase II the temporary roof would be replaced by a permanent structure. This allows the district to move immediately on the problem instead of putting the project out to bid given that the cost of this solution is under \$50k.

Ms. Ptak indicated that the recommendation is for phase I to construct the temporary roof. This would be completed over winter break.

Mr. Shein asked how the warranty on the temporary roof would be handled if a different vendor is used for phase II. Ms. Ptak indicated that this could be put in the specifications for phase II of the roof project.

MOTOIN TO APPROVE GBN ROOFING WORK

DISCUSSION/ACTION: STUDENT SERVICES REPORT

Dr. Williamson provided an overview of the student services report and presented data from the Illinois Youth Survey regarding student self-reported access and use of illicit substances. Information was also shared regarded students' perceived parental disapproval of this type of behavior.

Building principals and Student Services/Special Education administrators, Mr. O'Brien from GBS and Ms. French from GBN were on hand to respond to questions and provide clarification.

Mr. Hammer asked how students know how to access services and asked where suicide is covered in the curriculum.

Mr. O'Brien explained how students are connected with guidance counselors early in their high school career. Mr. O'Brien described a student-centered group called Erica's Lighthouse that

puts a face with information regarding suicide and issues such as depression. Mr. Pryma stated that there are hundreds of eyes on students each day. He described a recent front page story that ran in the GBN student newspaper, *The Torch*. The article described how GBN students are spearheading a depression awareness campaign.

Mr. Boron expressed concern that alcohol usage is far greater than cigarette usage. He also noted that parental disapproval for alcohol is less than disapproval for other drugs. Mr. Boron suggested focusing on this statistic.

Dr. Williamson stated that research indicates disapproval by parents and other significant adults regarding use of illicit substances can have a significant influence on student choices and behavior.

Mr. O'Brien indicated that we must work with parents to debunk the myth that rites of passage such as allowing students access to alcohol while they are in high school are a good thing.

Mr. Hammer cited another recent study that indicated many of these behaviors are much worse in college.

Mr. Wegley stated that it is important to note that the clearer a parent can be with their child regarding their disapproval of these types of behaviors, the better. He stated that the schools will continue to partner with the community and parents.

Mr. O'Brien stated that the school informs the parents regarding potential legal and financial consequences of student drinking. This is part of the curriculum that the school uses in their parent programming.

<u>DISCUSSION/ACTION: DASHBOARD - STUDENT AND STAFF</u> <u>DEMOGRAPHICS</u>

Dr. Williamson provided an overview of the dashboard reports regarding student and staff demographics. She noted that although GBS enrollment may grow significantly in the next ten years it is difficult to project beyond the next five years.

She noted that the district dropout rate has consistently been below 1% and last year neither school had any dropouts. Dr. Riggle made special note of this fact and that it is certainly a significant achievement and demonstrates how the school provide support for students to be successful.

Dr. Williamson reviewed special education trends.

Mr. Martin asked if the district tracks spending on special education programming. Mrs. Siena indicated that the district does in fact track this figure, but this can sometimes be unpredictable depending upon the students who come to the district.

Dr. Williamson explained that for the first time data regarding the percentage of teachers reaching tenure beginning with the 2003-04 school year is being reported. Going forward, this data will be compiled. It may be difficult to go back beyond 2003-04 given changes in financial and human resources software.

The Board asked about the tracking of spending on staff. Mrs. Siena indicated that this is a relatively large percentage of the total budget.

Dr. Caliendo indicated that the district is currently working on a distribution of lane and step by department to provide the Board with a greater level of detail.

DISCUSSION/ACTION: SEMI-ANNUAL REVIEW OF CLOSED SESSION MINUTES AND VERBATIM RECORDINGS

Dr. Williamson explained the process by which the Board must at least twice a year review closed session minutes and verbatim recordings to determine if these items are to remain confidential and if verbatim recordings may be destroyed 18 months following their creation, provided the closed session minutes have been approved.

Dr. Williamson recommended that the Board keep all closed session minutes and verbatim recordings confidential and that all verbatim recordings, except the recording from October 25, 2010 be destroyed.

Mr. Boron asked if there were any recordings relative to litigation other than October 25. Dr. Williamson indicated that there were no other recordings related to litigation.

MOTION TO APPROVE THE RECOMMENDATION REGARDING THE SEMI-ANNUAL REVIEW OF CLOSED SESSION MINUTES

Motion by Mr. Boron, seconded by Mr. Wolfson to keep the closed session minutes outlined in the memo confidential

DISCUSSION/ACTION: BOARD POLICY - 7030 SUMMER SCHOOL

Dr. Riggle reviewed changes in the summer school policy.

He noted that the district may charge up to 110% of costs to non-resident students. Non-residents will also be required to submit a health exam and immunization records. This physical could be used as a sports physical in the student's home district.

Language was added to address summer school issues through the school instead of going directly to the superintendent. The policy also speaks to a report regarding enrollment and financial statistics.

Dr. Regalbuto asked for clarification regarding the designated building principal if the student is a Loyola Academy student. Dr. Riggle clarified that depending upon which of the Glenbrook High Schools hosted summer school, that building principal would be responsible for responding to summer school issues under this policy.

Dr. Riggle clarified that residency and financial aid issues would come to Mrs. Siena. This change builds in another layer of people involved in the process.

Another change in the policy allows the district to reduce staff if sufficient enrollment is not obtained to run a class. Summer school must be self-supporting and paid for through registration.

Dr. Riggle explained that all elementary and high school programs are offered by GBN, but at GBS the Glenview Park District has

been running all elementary programs. The district will continue to collaborate with the Glenview Park District at GBS for summer programs. Materials for these programs are approved by the district.

Summer school new courses, programs and materials must be approved by the Board, as is done for courses running during the regular school year.

Dr. Riggle stated that the summer school policy will be placed on the consent agenda at the next Board meeting.

MISCELLANEOUS TOPICS

Dr. Riggle reminded the Board that tomorrow night there is a holiday concert at both schools. There is also a Wednesday morning performance offered.

Mr. Pryma mentioned that GBN assistant football coach, John Real, has been battling cancer and just entered hospice. John is a legendary coach who has given his all during his entire career.

REVIEW AND SUMMARY OF BOARD MEETING

President Shein reviewed the following:

For students and staff who excel, the Board recognized a GBN tennis player and a GBS swimmer. The GBN Beating the Odds Club members were recognized for their efforts in supporting GBN teacher, Jon Sorkin.

The Board held a public hearing on the tax levy. Northbrook resident, George Stutz, posed questions to the Board regarding this topic.

The tax levy was approved 6-0 in a unanimous vote and direction for reapportionment for the 2010 extension was given to the Cook County Clerk.

The Board review the financial report and certificates of excellence earned by the district's financial team. Assets were reduced by \$40M through the audit process.

The Board approved an emergency roofing project at GBN, awarded the transportation bid and took action regarding closed session minutes and verbatim recordings.

MOTION TO MOVE INTO CLOSED SESSION

(Section 2(c) (1), (2), (5), (9), (10) and (11) of the Open Meeting Act.
