Special Note

Prior to the adoption of the 2011 Tax Levy, the President of the Board of Education will conduct a public hearing on the proposed tax levy in compliance with the requirements outlined in the Truth in Taxation Act. In accordance with the Act, no public hearing is required for the 2011 Tax Levy, due to the fact that the levy increase is less than 105% of the preceding year's extension. Although not legally required, the Board of Education has determined that it is in the best interest of the community to conduct a public hearing and welcomes public comment.
