This email is in response to your FOIA request received February 28, 2011.

As the district's FOIA officer I am notifying you of our intent to deny this request for the following reason:

Section 7(1)(c) of FOIA exempts from disclosure personal information contained in public records if disclosing that information would constitute a clearly unwarranted invasion of personal privacy for the person or persons the information pertains to. Personal information has been defined by the courts as information "that is private and confidential. For purposes of subsection 7(1)(c), an unwarranted invasion of personal privacy means "the disclosure of information that is highly personal or objectionable to a reasonable person and in which the subject's right to privacy outweighs any legitimate public interest in obtaining the information."

Under the Freedom of Information Act, information of this type involving student disciplinary matters cannot be shared.

The District has filed a FORM FOR PRE-APPROVAL OF USE OF EXEMPTION 7(1)(c) - unwarranted invasion of personal privacy with the Public Access Counselor (PAC) with regard to denying the request based upon this exemption. Once the district receives a ruling from the PAC, we will respond.
