RE: DISCUSSION/ACTION: APPROVAL OF GBN PAVING BID

Recommendation

It is recommended that the Board of Education approve a paving bid to Allstar Asphalt in the amount of \$97,200.

Background

As part of the district's long-range paving plan, the GBN parking lots to the south of the CPA and the A Building are scheduled for replacement this coming summer 2010. Originally the Village of Northbrook required the addition of a four inch layer of BAM to both parking lots. This is a fairly new requirement and one that is not required in the majority of contiguous communities, including Glenview. After negotiations with the Village, the Village decreased its requirement and only asked that the district put BAM in the parking lot south of the A building. Since this lot is used in the same manner as the lot just south of the CPA where the Village was no longer requiring BAM, the district and ARCON continued discussions with the Village and took core samples of the lot in question. Dr. Riggle also had a conversation with Mr. Nahrstadt, the Village Manager of Northbrook, where it was agreed that the **district did not have to install BAM in either of the new parking lots at GBN**. Had the Village required the BAM, it would have cost the district an extra \$31,329. See attached letter from Paul Kendzior, Village of Northbrook engineer.

Based on the submitted cores of the existing pavement areas to be rehabilitated (milled/resurfaced) in the south parking lot at Glenbrook North High School, the pavement sections following the proposed milling/resurfacing work are approved. The core taken at location #1 indicates the existing pavement section is an equivalent alternative to Village standards.
