In response to recently released IRS regulations establishing a requirement for written documentation of the 403(b) tax sheltered annuity program offered to employees of Northfield Township High School District 225 (the "District"), the District wishes to adopt the plan document, consisting of the 403(b) Plan Document For Northfield Township HSD 225 and the Adoption Agreement For 403(b) Plan Document For Northfield Township High School District 225 (both of which are referred to hereinafter as the "Plan Document"), a copy of which is attached to this resolution. The Plan Document is based on model language released by the IRS for such purpose.

**FURTHER RESOLVED** that the Board authorizes the Assistant Superintendent for Business Affairs or his/her designee to act on the Board's behalf with respect to this plan, and to take any and all actions necessary or desirable to implement, maintain and administer the plan set forth above in accordance with the Board's intentions, and all applicable state and federal laws.
